Hope as a Bar

I recently read an interesting article in the Wall St. Journal about hope. This article ascribed four qualities to people who have hope, qualities that all hopeful people possess and all hopeful institutions share.

The first quality is competence. Hopeful people are confident in their abilities, their capacity to acquire new skills, and refine the skills that they possess. The basis of our profession is grounded on competence, that is why they call what we do a practice. The operative premise is that we build on our skills and the more we do it the better we become.

The second quality is *survival*. Hopeful people are people that prevail, often against great odds. Law exemplifies survival as a central tenant of what we do. Whether it is the contest of litigation, the exercise of negotiation, or the persuasion of an argument, we lawyers are our clients' fiduciaries helping to assure their well-being, their security, their freedom-indeed their figurative if not literal survival often against great odds. In turn, we diligently prepare our cases, expecting to prevail and be even better prepared to handle the next case. In this sense, our Katy Bar Association helps to promote and insure the survival of our profession and not merely the propagation of law as a mere business.

The third quality is attachment. People are social animals- we do not operate in a vacuum. We need others and reach out to others. We relate to judges, juries, clients, staff, and our peers daily. Our Bar Association facilitates professional attachment on many levels: professional, educational, and interpersonal. Our hopes are validated by those that we serve

and those whom we love. We accept these attachments because we share a belief that we are called to the law. It is what the ancient Romans called a "vocation," that which we are called to do.

The final quality is *spirituality*. Every interview I have ever read or seen with an astronomer or astrophysicist always starts with the tale of a woman or man who stared into the night sky as a child and wondered at what all this meant. Without reference to any particular religion, belief, or creed, spirituality imparts to each of us a sense of humility that starts with the realization that life is finite and thus defines our limits and place in the universe. Our Bar Association enables each of us to better make use of our abilities in a sphere beyond ourselves, that is, in the service to our profession and to others.

So, the Katy Bar is no bar to hope, it exemplifies hope. My hope is that we can build upon what we have created and improve it and ourselves in the service of our chosen profession and the public trust in which we have been invested.

REPORT FROM SCHOLARSHIP COMMITTEE

2016 KBA SCHOLARSHIP PROGRAM REPORT

KBA's 2016 scholarship program combined KBA's desire to assist deserving KISD 2016 seniors in paying future educational expenses with the State Bar's Law Day competition. On February 3, 2016, KBA provided descriptions of the program requirements to all KISD high schools, soliciting submissions of posters, photographs, and editorials meeting the requirements of the State Bar's contest.

KBA received only editorial submissions. Though the original plan had been to award scholarships of equal amounts to the winner in each category, the Scholarship Committee decided to award the three scholarships to three students who had submitted editorials, having determined that all three entities were worthy. The scholarships were awarded to these three KISD seniors:

Alex Pratt – Seven Lakes High School

Pranay Tamminayana – Seven Lakes High School

Jennifer will attend college at Texas A&M in College Station, where she plans to earn a degree in Biomedical Sciences, with a planned advanced degree and career in Veterinary Sciences. Pranay plans to double major in Business and Public Health at University of Texas in Austin, after which he aspires to earn M.D. and M.P.H advanced degrees and enter a career in public health. Alex will attend Baylor University, where he plans to major in Communications and English, with the intent to attend law school following graduation.

The Scholarship Committee selected Alex Pratt's editorial for submission to the State Bar competition. (Only one entry could be submitted.)
