#### KATY BAR ASSOCIATION 2017 LAW DAY COMPETITION

For many years, the Katy Bar Association has sponsored a scholarship program. The selection criteria and amounts awarded have varied over time, but two constants that have guided each year's competition are KBA's focus on encouraging students to pursue post-secondary education or training and increasing awareness of the value of our country's legal system. Beginning in 2016, we decided to base our program on the themes of the State Bar of Texas's Law Day celebration and coordinate our local competition with the State Bar's statewide Law Day competition. Law Day is the annual celebration of the system of laws that guide and support our way of life. The competition theme this year is "The 14th Amendment: Transforming American Democracy." The KBA opened its competition to all KISD high school students, inviting them to submit editorials responding to this prompt: "Why is it important that all people receive equal protection of the laws?" The editorials received in response were thoughtful, scholarly, and inspiring. Each student tackled the prompt with different perspectives. Selecting the winners was a difficult task.

Ultimately, our Education/Scholarship Committee chose the following winners:

The KBA will award the students monetary recognition ranging from \$250 to \$1,500 to be used for educational purposes. The awards will be presented to the students at our April 25, 2017 general meeting. KBA has invited the parents and principals of the students to attend as our guests.

The State Bar invites each local bar association to submit its first place winner to the State Bar's statewide competition, so we entered Jun-Yong's editorial and were thrilled and honored to learn that his essay had been chosen as the FIRST PLACE editorial in the statewide Law Day contest. The State Bar has invited Jun-Yong to attend the award luncheon in Austin on May 1, 2017, where his editorial will be read as part of the program. Congratulation, Jun-Yong!

The Katy Bar Association simply could not be any prouder of these students. Whenever you hear curt dismissals of Generation Z, keep these winners (and our other contestants) in mind. They are proof that our future will be guided by caring, open-minded, and intelligent people.

## JUN-YONG KIM "Monsters of My American Dream"

My boogeyman didn't come from my closet with four flailing arms - it came from school in the form of twenty-six letters. After moving to the United States from South Korea, I sat helpless in classrooms with my limited arsenal of words as the beast of the English alphabet overwhelmed me. I watched my peers laugh and yell while I was spoon-fed the American Dream in an unintelligible language. From the beginning, our country has clashed when interpreting what the 14th Amendment truly guarantees. We've vacillated in ideology, from *Plessy v Ferguson* to *Brown v Board of Education*. But when it comes to parity in schools, it's not so much about who's right, but rather, who's left. Without the 14th Amendment, millions in the United States would be left not only without proper rights, but more importantly the opportunity to thrive. Sure, the pursuit of equality is far from easy. But the United States is America because it chooses not what's easy, but what's best. Luckily, America has given me every opportunity to keep up with my English speaking peers. In the 1974 Supreme Court case *Lau v* 

Nichols, Justice William Douglass argued," students who do not understand English are effectively foreclosed from any meaningful education," in essence violating the 141 Amendment. The Lau decision disallowed for ignoring English learners and paved the pathway to ESL programs for students like me, in need of extra assistance. No more did I cower in the face of the English language; with bilingual programs to integrate me into society, I was able to break the wall of language holding me back. No more am I hopeless; instead, I now use English as my tool to not just explain my thoughts, but to provide a voice to the voiceless. My local school district, Katy ISD, has been integral to my academic awakening. It prides itself on truly leaving no child behind with its promise to not "discriminate on the basis of sex, disability, race, religion, color, gender, age, or national origin", and hence has become one of the best in the state. For the fourth year in a row, every campus met all four accountability indexes of performance, including increased academic achievement for economically disadvantaged students and underperforming ethnicities. Katy ISD has been a champion of acceptance, equality, and has become a bastion of exemplary performance. That's what equal protection under laws provides- it gives every student herein Katy the ability to dream without fear of discrimination based on color, money, or gender, from the immigrant to the impoverished to the handicapped alike. I once was told that the American Dream is called that because you have to be asleep to believe in it. I beg to differ. The American guarantee of equality has instead shackled my nightmares and freed me to dream in real life. The monsters in my closet are on an unending Sabbatical; the only beast left is my drive to capitalize on every opportunity equal protection offers me.

The Equal Protection Clause has been a center of controversy for many years seeing as it is easily applicable to a variety of situations and circumstances. So what makes such a simple principle a source of such public discord? I believe that one of the most important principles of American History is the promise of freedom and the guarantee of protection under the law. It is important that all people receive equal protection to continue support of American-held values, prevent historical disasters, and because it is logically sound for the perseverance of a fair society. John Locke led beliefs of natural rights; innate freedoms that all human beings were guaranteed and such enlightenment thinking led a few British colonists to form one of the greatest nations in history. Human beings are all divergent with contrasting ideals, desires, talents, and skills, but deep down beneath our differences we are all human beings. Humans deserving the same privileges and protections; necessary for the prevention of disillusionment. Equal protection, unfortunately has not been guaranteed to others in the past. Beliefs that not all human beings deserved the right to protection, or even humane treatment is a part of our country's past. When we denied equal protection to individuals what did it lead to? Complete and utter disillusionment and polarization. Our country fought an entire war against themselves and the spent decades trying to redirect the nation. All people deserve protection because denying anyone freedom is distorting the beliefs of freedom itself and allowing it and America to become destroyed. Equal protection under the law and its application to all people is important because it not only stands for the ideal and principles of our founding fathers, but also the realities of humanity. There is no person greater than another or more deserving of freedoms, it is a choice to be exercised by all and a guarantee that not only is the foundation of our being but an instrumental part of the creation of America. The thing about equality is that it is not something that can be given, but something that every individual has the capacity to receive. Insurance that every individual is provided with the same rights, treatments, and protections ensures that every individual can live up to their potential and improve the quality of life and society as a whole. It is in the best

interest of a fair society to instill within its member's beliefs of equality to create stronger relationships between individuals and help inspire everyone toward a common goal. Disenfranchising one people group from this equal protection hurts society more than helps it by ensuring defiance against laws rather than compliance and destruction in the trust and authority of a ruling body. Equal protection for all is necessary for a fruitful and strong nation.

Without equal rights being made accessible to all, the foundation our country was built upon crumbles. Because of this standard of equality set forth in both the Declaration of Independence and the Constitution, I have gotten the opportunity to see children and young adults at a camp specifically for those with disabilities ride horses, sail across the sky on a zip line, and splash around in a swimming pool. I have been able to help in a classroom of a young boy who was refused the right to an education in his country overseas but then graciously accepted and valued in a school in this nation. I have heard of students who were able to graduate college, join the work force, and stand up for rights despite their physical and mental hindrances. These are only a few of the many times I have seen equal rights radically influence the lives of others. There are so many other stories and so many other people who are affected by equal rights and who are enabled to live the lives they love and have dreamed of. Equal rights are necessary because without them America is not by the people and for the people. Equal rights play important roles across many different categories people may fall in, but watching the way they completely shape the lives of those with disabilities makes me proud to live in a country that promises equality to all and views it as a necessity not just when it is convenient.

#### **KBA JUDGE SARAH SPRINGER SCHOLARSHIP**



#### UPDATE ON HARRIS COUNTY CIVIL COURT BUILDING ELEVATORS

From Judge David Farr: I know that there has been tremendous frustration with the status of the elevators at 201 Caroline so I am sending this update in order to bring you collectively current on that issue. Harris County is undergoing a modernization of all 6 elevators to floors 8 to 17 in the Civil Courthouse. That means they are replacing equipment, such as drives, controls, electronics, cables, etc. The Harris County Commissioners Court voted yesterday to bypass the bid process and to go directly to Otis Elevator to begin this process. It will take approximately 16 weeks to manufacture and deliver the new equipment. Once the new equipment is delivered, it will take an estimated 6 months to complete the installation (March 2018). The work will be done 2 elevators at a time. If they can do 3 at a time they will. Because of the problems with the upper level elevators the freight elevator has been used for the general public during the highest traffic period of 7:30 am to 9:30 am. Unfortunately, the freight elevator sustained water damage last week due to a relief valve that failed. The parts to repair this elevator have been delivered and it will take another 2 weeks (estimated) to complete that repair. The good news is that there will be newly repaired (and different brand of) elevators this time next year. Meanwhile, we will continue to use the freight elevator when available so please be mindful of delays as to your arrival times for dockets and as to late calls to the courts. Thank you for your patience as the county works through these issues.



#### **DUTIES OF KBA OFFICERS**

# ARTICLE 3 Officers and Directors.

<u>Section I.</u> The Officers of this Association shall be a President, First, Second and Third Vice-Presidents, Secretary and Treasurer. The duties of these Officers shall be as follows:

- **a.** President: Shall preside over all meetings and shall be the Chief Executive Officer of the Association.
- **b.** First Vice-President: Shall assume the duties of the President in the President's absence and shall participate as an *Ex Officio* member of all Committees.
- **c**. Second Vice-President: Shall assume the duties of the President in the absence of the President and First Vice-President and shall chair the Programs Committee. The Second Vice-President is responsible for securing speakers for each regular Association meeting who shall provide programming eligible for Continuing Legal Education credit from the State Bar of Texas.
- **d**. Third Vice-President: Shall assume the duties of the President in the absence of the President, First Vice-President, and Second Vice-President and shall chair the Education Committee. The Third Vice-President shall secure approval of eligible Continuing Legal Education programs from the State Bar of Texas and shall be responsible for transmitting participant information to the State Bar of Texas for credit to the participants' Continuing Legal Education records.
- **e**. Secretary: Shall keep the minutes of all meetings, the Association's records, and attend to correspondence. The Secretary is authorized to attest to all actions of the Association.
- **f**. Treasurer: Shall keep well and truly the Association's books of account and membership lists of the Association. The Treasurer is authorized to transact all banking business on behalf of the Association. The Treasurer shall also serve as the tax officer of the Association.
