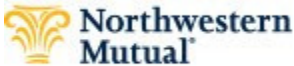

I joined the KBA in 2007 after I moved to Katy from Mississippi, where I had just been un-elected to the Chancery Court Judgeship I had held since 1994. I knew no one, and I wanted to find my place in Katy's legal community. The meetings were held at Landry's at the time, and I saw then President Kathy Black running the meeting and taking minutes. I volunteered to take the minutes on one condition: everyone who spoke had to first identify themselves. Pretty soon I was in the fold and found wonderful friendships in the Katy Bar.

I served as secretary for the next six years, then I was first Vice President under former President Nick Nicholas, and I was honored to be elected President three years ago, following in the giant footsteps of past President John Kelly. Over the years, I have seen the Katy Bar grow in positive ways, and I have seen colleagues forming friendships and alliances as we promote the image of lawyers in the Katy area.

Whenever I find a "West Houston" lawyer representing Katy folks, I always urge them to join the KBA. I have been told by many members that they get more referrals from KBA lawyers than any other group.
