### TOPIC FOR OUR SEPTEMBER CLE: INTRODUCTION TO THE TEXAS MEDICAL FUTILITY STATUTE – WHEN DOCTORS AND PATIENTS DISAGREE

Brief Course Description: End-of-life questions arise frequently. While such questions are much easier to resolve when an advance directive is offered, such directives are not always provided. This presentation asks the question, "What is medical futility and what happens when Physicians and Patients disagree about end of life decisions?" We will review how medical dispute questions have been interpreted by the courts and how common law has, with regard to this subject, changed over the years. Specifically, what rights do patients have under Texas Law? What are the moral, ethical and legal implications of this these decisions, and who, under Texas law, makes the final determination? We will review several cases that have made their way before Texas and other state courts and review the legal issues and principals applied. We will ask if these decisions were made correctly, and what legal arguments might one make to persuade the courts to rule differently?

## The DOL Has Been Busy: Keep Up With Fall Changes and the FLSA Salary Increase Amendments Coming to You on December 1, 2016.

Effective on December 1, 2016, exempt executives, professionals, and administrators must be paid a minimum salary of \$913 per week (\$47,476 annually), which more than doubles the current minimum salary required to maintain those exemptions. A portion of the required minimum compensation may derive from nondiscretionary bonuses.

Many KBA members practice in small firms, but remember that these new rules apply to all employees covered by the FLSA, not just employees of large businesses. FLSA coverage may apply to an entire enterprise based on its revenues or to individual employees based upon their work activities. The Department of Labor (DOL) website offers information concerning the scope of FLSA coverage.

Businesses that employ personnel currently classified as exempt for FLSA purposes, but who earn less than \$913 per week in salary, must decide how the new minimum salary requirements affect their compensation structures. Remember that an employee is entitled to overtime pay unless he satisfies both the "duty" and the salary requirements for the particular exemption applied.

Hessam Parzivand, guest speaker at KBA's June meeting, provided an overview of the core changes and the need to take action. KBA member Elizabeth Pratt's May 2016 and August 2015 blog posts (http://elizabethprattlegal.com/#1/blog) also provide information about the amended regulations and suggestions of how to minimize the impact of compensation changes on business finances and employee morale. The DOL website also provides a great deal of information.

Timekeeping rules and limits on compensable work time are important components of a compensation structure that minimizes overtime costs (and wage claims), so employers should get busy planning now if formerly exempt employees will be reclassified to non-exempt status.

Covered employees should also keep in mind that the DOL has issued a new FLSA poster for all employers covered by minimum wage requirements. The new minimum wage poster is already in effect and should be posted in a conspicuous place in establishments where covered employees work.

Capping off these changes, the DOL also increased its civil money penalties effective on August 1, 2016. The DOL may impose a penalty of up to \$1,100 for each repeated or willful violation of its minimum wage or overtime requirement, typically assessed per-person.

The clinic will be held at the Katy VA Outpatient Clinic, 750 Westgreen Blvd., 2<sup>nd</sup> Floor, Katy, TX 77450 from 9:00 a.m. until noon. No appointment is necessary. The clinic is a public service of the Katy Bar Association and the Houston Bar Foundation's Veterans Legal Initiative.

Any veteran, or spouse of a deceased veteran, can receive one-on-one advice and counsel at the clinic from a volunteer attorney in any area of law, including family, wills and probate, consumer, real estate and tax law, as well as disability and veterans benefits. Veterans who need ongoing legal representation and who qualify for legal aid will be assigned a pro bono attorney through the Houston Volunteer Lawyers to handle their case.
